2. **Structure of Selection Process**: - Selection process will consist three steps i.e. written examination, Class Demonstration and Interview. A candidate will be required to score minimum 33% marks to qualify for the next step of the selection process. However, the minimum required marks may be increased upto 50% by the Board of Officers to limit the number of candidates for the next step of the selection process.
